- (f) PC at the FITASC general assembly this year, it was agreed that as an experiment provision will be made for a Masters team in the Helice European and World Championships in 2024.
- (g) MDR if there are emails being sent about the agenda and items to be listed, then she should be included in the loop bearing in mind she drafts it!
- (h) NJW There is a possibility of GB hosting the FSP European

Championships in 2025/2026. They have a ground in mind but need to talk to them., whereupon they may come back to the Board with a proposal.

NAH urged caution after what happened last time, there needs to be a clear contract and budget produced to enable the Board to decide.

RH queried whether they were looking at just one ground or others.

NW said they had Hodnet in mind but that does not exclude any others expressing an interest.

EB said she could ask SCTA to open it up.

MH – would love to host it. Castle and Greenfield site last time did not work. Any ground can be considered but need to bear in mind airport location etc. NAH – Declaration forms must be completed 12/14 weeks in advance.
