

# COMPAK Sporting Survey 2024 The Results

# Purpose of the 2024 survey


- The BICTSF COMPAK sub-committee wanted to hear the competitor's views and thoughts on how the costs on the entry fee that are currently paid for the BICTSF championship shoots could be reduced.
- The point where a change would be made was if there was a clear majority of at least 66% in favour of any of the possible changes proposed.

- In total 230 surveys were e-mailed to the shooters.
- 93 responses were received.
- 40.43% response rate.

#### **Question 1:**

Currently the BICTSF pay for BICTSF COMPAK qualified referees and one COMPAK Chief Referee to officiate at all BICTSF championship shoots. The cost of this is added to the entry fee and is not currently included in the Ground's green fee. Would you support the use of the ground's own referees officiating at BICTSF Championship shoots?


Of the 93 responses received 92 voted on this question



#### Question 2:

Currently £10 of your entry fee goes to the cash fund for each BICTSF Championship shoot to be evenly distributed between the classes and includes a high gun prize. Does BICTSF keep it as a mandatory cost within the entry fee or do we give you the option to pay £10 into your individual class fund or not with there being no high gun prize

#### Question 3:

Part of the entry fee is used to support the individual entries for the shooters representing GB at the European and World Championships as well as the cost of the team entries. Currently the individual and team entries for these 2 shoots equates to approx. £9,000 per year. If the individual European and World Championship entries became the responsibility of the individual shooters to pay, then the costs would reduce to approx. £1,200 and therefore reduce the money required from the entry fee.



#### **Question 4:**

Currently it costs approx. £130 for medals to be provided at each BICTSF Championship shoot. This cost is currently budgeted for in each BICTSF Championship entry fee charged.

#### **Question 5:**

BICTSF has been requested to consider changing the BICTSF Championship 100 target competitions (shot over 4 layouts) to 125 target (shot over 5 layouts) competitions.

Note: The British Grand Prix will remain a 150-target event.

# **Survey Conclusion**

As can be seen by the survey results, the shooters have decided that none of the proposals made should be implemented as none achieved the necessary votes of 66% in favour of change.

One change for next season which will be implemented is that the referee costs will now be shared between the grounds and BICTSF.

The grounds holding the shoots for you will be required by contract to pay the referees up to the amount that they would offer their referees for a registered event with BICTSF making up the difference as we continue to use BICTSF qualified referees.
